June Delivery (May Data)

ETF – Additional Attributes

Adding additional attributes to Exchange Traded Funds including: ETNs, HOLDRs, Leveraged ETF, Currency ETF, Commodity ETF.

Hedge Fund – Additional Data Points

Additional strategy, operations, and hedging data.

SAI Data Points

New sub-advisor data points will be added, including sub-advisor fees and brokerage commissions collected from the statement of additional information.

Standardized Return Revisions

Morningstar will calculate quarterly standardized performance from the adoption date of subaccounts in the separate account, which may predate the inception of subaccounts in the policy.

\$ Stewardship Data

A new data license that allows clients to conduct comparisons using key manager-, fund, and firm-level stewardship statistics.

\$ VA MARC Essentials

Use of MARC policy or company level data points in mass media such as websites, sales brochures, and advertising.

September Delivery (August Data)

Index Revisions (occurring 7/31/08)

Changes to the primary index assignments for the Categories in the new Alternative broad asset class and changes to seven secondary indexes for seven other Categories.

New Categories (occurring 7/31/08)

New Categories for Global Real Estate and Currency, removing Muni Florida.

Primary Index Revisions for Hedge Funds

Primary indexes will now be assigned to Morningstar hedge fund indexes for more appropriate comparisons and calculations.

\$ Glide Path Data

Morningstar will group together all target-date maturity funds in a particular series and provide their years to/after retirement and detailed asset allocation breakdowns. The data is collected from the prospectus and will allow you to either build your own glide path or license glide path images from Morningstar.

\$ UIT Data

Performance, portfolio, and operational data for US-based Unit Investment Trusts.

Future Releases

Acquired fund expenses (planned)

Adding more detailed expense data by including underlying fund expenses for fund of funds.

Asset Management Role (planned)

Data that differentiates between managers and other members of the management team/investment committee.

Bear Market Return (planned)

The return will equal the return that the share class had during the most recent bear market. The bear market rank will be calculated according to this new definition.

New Closed End Data Points (planned)

New fund expense data points.

Non SEC Tax Adjusted Returns, Ranks, Averages (planned)

These are after-tax returns for mutual funds, but they differ from the SEC specification in that we do NOT apply loads or assume liquidation in calculation.

Open End – New Investment Data Points (Planned)

Minimum Initial Investment: We will supply Minimum Initial Investment purchase information for Direct, Advice, Retirement Plan, Supermarket, and Institutional (if available in the prospectus).

Closed to New Investors: Similar to the above data point, this field will change in the future to additional distribution channels (the same as listed above).

\$ Australia and NZ SA/CIV Databases (planned)

Separate account data for Australia and New Zealand.

\$ Daily AUVs (planned)

Daily unit values for variable annuity/life products.

Pension fund data for Italy.

\$ *Market Price for CITs (planned)*

Additional pricing data for collective investment trusts.

\$ *Model Portfolio Performance (Planned)*

Morningstar will begin providing performance and portfolio statistics for goal-based model portfolios within retirement plans.

\$ *Public Pension Database (planned)*

Performance, expense, and portfolio holdings data for US pension plans.
